

In the later 1990's to early 2000's, he lead the team that developed the China telecommunications market entry strategy for two Top Ten Fortune 500 companies, a U.S. telecommunications company, and a U.S. computer company where the financing package involved over USD100 million. He is Phi Beta Kappa and summa cum laude graduate in economics from the University of California at Davis and a graduate of the University of Southern California Law School. He and his family have lived in Beijing, China since 2001.
